APPLICATION AND SELECTION PROCESS

- Applications for Associateship positions will be accepted through the official FFDC website or designated channels.
- Applicants must submit all required documentation and meet the eligibility criteria to be considered for selection.
- A selection committee will review applications and shortlisted candidates will be invited for an interview.
- The selection committee's decision is final and binding.

The duration of the Associateship program will be one year Associates are expected to:

TERMS & CONDITIONS:

- **Selection Process:** Applications for Associateship will be reviewed by a committee constituted by FFDC, Kannauj based on established criteria, including relevant experience, qualifications and potential contribution to FFDC's goals.
- **Duration:** Associateship is initially granted for a period of one year, with the possibility of renewal based on mutual agreement and satisfactory performance.
- **Annual Fees:** Rs. 1,50,000/- (Registration Fee: Rs. 42,480/- including GST) (Lodging & Boarding (sharing): Rs. 1,07,520/-)

- **Intellectual Property** (**IP**): Any intellectual property developed during the associateship will be the property of FFDC. The associate agrees to promptly disclose and assign any such intellectual property to FFDC.
- **Confidentiality:** Associates are obligated to maintain confidentiality regarding FFDC's proprietary information and research findings.
- **Reporting:** Associates are expected to submit periodic reports to FFDC on their activities and contributions to the program.
